INDEPENDENT AUDITOR'S REPORT

To the Members of Staytop Systems and Software Private Limited

Report on the Standalone financial statements

We have audited the accompanying Standalone financial statements of Staytop Systems and Software Private Limited ("the Company"), which comprises the Balance Sheet as at March 31, 2016, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

 - ii. The Company did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses.




Inherent Limitation of Internal Financial Controls over Financial Reporting
